



## Old Testament Court System

Accuser and Accused argue own cases

Burden of proof on defendant

 Testimony of at least 2 witnesses required for conviction

## Old Testament Court System

Cases of false testimony were referred to the central court.

Accused could submit to an ordeal or an oath to prove innocence.

Casting lots to discover guilt was sometimes done.

## Old Testament Court System

Judges responsible for administration of punishment.

Court system only functioned well when community agreed with decisions and cooperated to enforce them.

By judging justly, courts taught God's law and principles of divine justice.

#### Witness Oaths

Do you solemnly swear (or affirm) that the testimony you may give in the matter on trial will be the truth, the whole truth and nothing but the truth, so help you God?

Texas Rules of Evidence, Rule 603

#### Juror Oaths

#### FOR SUMMONED JURORS

You, and each of you, solemnly swear that you will make true answers to such questions as may be propounded to you by the court, or under its directions, touching your service and qualifications as a juror, so help you God.

Texas Rules of Civil Procedure, Rule 226

#### Juror Oaths

#### FOR SELECTED JURORS IN A CRIMINAL CASE

You, and each of you do solemnly swear (or affirm) that in the case of the State of Texas against the defendant, you will a true verdict render according to the law and the evidence, so help you God.

Art. 35.22 Texas Code of Criminal Procedure




